Step 1: Complete the LSW Dual Credit Application

- Download application on LSW Website: https://lswhs.lsr7.org/class_applications/
- $\Box\,$ Submit completed application to the LSW Counseling Office by Feb. 18^{th}
- Reminder: For students that have not yet completed the ACT, the Accuplacer Placement Test will be required
- □ Students that have not submitted the completed Dual Credit Application, will be withdrawn from dual credit course
- □ Dual Credit Applications are required for the following courses: College English, College Statistics, and College Algebra (sem & yr long)

Step 2: Complete the MCC-Longview Online Application

- □ Complete the free, online application for Metropolitan Community College at <u>https://mcckc.edu/apply-now/</u>.
- □ Reminder: The application must be completed at least 2 business days prior to taking the ACCUPLACER Test
- □ Provide your email address as part of the MCC application. This will allow MCC to forward an individualized "MCC Student ID #" to your email address within 48 hrs.
- □ Reminder: Students that have not completed the application, will not be issued an MCC ID or Testing Voucher, which is required to participate in the Accuplacer on Feb 17th or 24th, 2021.

Step 3: Sign-up for the Accuplacer in the LSW Counseling Office

- □ Register for the Accuplacer via the LSW Counseling Accuplacer Sign-up Sheet no later than Feb 15th for the Feb 17th Test Session, and Feb 22nd for the Feb 24th Test Session.
- □ Reminder: A virtual preparation workshop will be held to assist students with ensuring each participants Chromebook is compatible with the Accuplacer testing platform (Link will be provided)

 \Box Students will have the option to select 1 of 4 testing windows (Feb 17th am/afternoon session, or Feb 24th am/afternoon session).

Morning Session-7:30am checkin, 8:00am testing begins Afternoon Session-11:30am checkin, 12:00pm testing begins

 \Box Please bring a copy of your MCC ID #

-MCC will provide an email confirming your MCC ID within 48 hours of submitting an application -Students will not be permitted to complete the Accuplacer without an MCC ID #

Please bring a photo ID
-Students must have a photo ID to participate in the Accuplacer.
-Students will not be permitted to complete the Accuplacer without a Photo ID
-Examples of Photo ID's (LSW School ID, Drivers License, State ID)
