REQUIREMENTS FOR ENROLLMENT

- Enrollment in College Algebra requires a 3.0 unweighted GPA and a minimum score of 22 on the Mathematics portion of the ACT (or an Accuplacer score 50 or above in College Algebra, or 116 or above in Elementary level Algebra, or 240 and above in Accuplacer Next Gen AAF). The student must be a junior or senior student who has received a C- or higher in Algebra 2.

Note: If your unweighted GPA falls below 3.0 or you have not met the ACT/Accuplacer score prior to the first day of school, you will be removed from College Algebra enrollment and placed in an alternate course.

ATTENTION: If all enrollment requirements for the college credit class are not met, a student will be placed in an alternate course. All requirements are subject to change per UCM course requirements.
