General Information for all ACT Test Prep Classes

Each ACT Test Prep Session costs \$40. Each session consists of 4 classes. To sign up for one of the sessions, students should speak to Mrs. Melissa King in the Counseling Center. To pay for the session, a check for \$40 should be written to Lee's Summit West High School and given to Mrs. King.

Students have experienced impressive test score gains from our classes. To achieve that same success, please follow these guidelines:

1. Students should read all of the information in the email that their instructor sends them about the class, including the information on the document that their instructor shares with them, to ensure that they are prepared for each class.
2. Students should pick up the materials they will need for the class, including the pre-test, post-test, and workbooks, from Lee's Summit West High School. Students should refer to the email and document that their instructor shares with them for more information on how to pick up these materials.
3. It is critical that students attend all 4 classes in a test prep session. The four classes include a pretest, two classes of instruction that utilize the pretest as a teaching tool, and a post test.
4. Students need to have a pencil and a calculator. In addition, they should also have their pretest and the instructional workbooks for the second and third classes.
5. To receive the full benefits from the class, students need to be on time and attentive. We will ask them to turn off anything that might distract them during the class.
6. In addition to the four classes, students will have extra practice opportunities in the workbooks they receive.
7. Students who have registered to take the ACT can also access ACT Prep information at <http://www.actstudent.org/onlineprep/> using the information they used to create an account and register for the test.

Please note that while we have scheduled the classes to lead up to a specific test date, the cost of the class does not include the registration cost of the actual ACT. Students should register and pay for the test online at <http://www.actstudent.org/regist/>.
